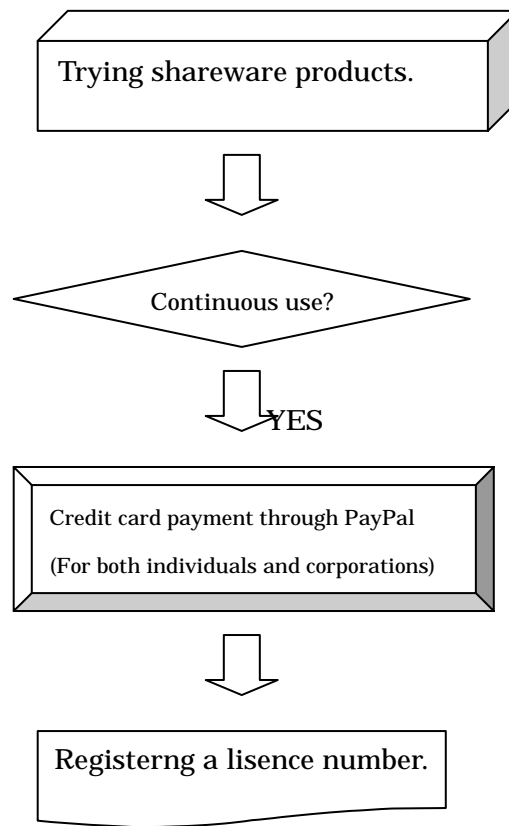

You cannot use our shareware products continuously after passing over a trial employment period. Here, the user's registration method (individual) or license in the case of continuing and using shareware products, and the remittance method of a contract (corporation) and a price is explained.

1.1The flow to price remittance

- 1. Shareware Products (the Trial Version) are downloaded.
It loads.
- 2. Do you try and purchase this product?
Please judge in this trial period.
- 3. When Determined to use it continuously ,please perform remittance procedure.
-Credit card payment through a Vector share register (individual)
- 4. If remittance is checked
-Lisence number is sent by e-mail..
- 5. Register a license registering number and complete.
(Even if a version is updated, it can continue as it is and can use.)



2. User's registration

It is a product of shareware and the product of Seiken-Soft Service Co Ltd (henceforth "KSS").

User's registration is required to use continuously exceeding a trial period.

Although no restriction will impose you during the trial period (for 20 days) from after installation, it becomes impossible to start if it passes over a term.

When you stop use after the end of a trial period,, please be sure to uninstall.

* Keep in mind that registry information is not deleted only by deleting a program.

There are two kinds of registration methods, individual registration and corporation registration, in user's registration.

2.1 Contents of Individual Registration

Number issue	Sent by e-mail after check of receipt of fee.

2.2 Contents of Corporation Registration

Object user	Corporation user
The number of use	The number contract of PC, or the department division licensing agreement
Licensing agreement certificate	Licensing agreement certificate issuing
Sales method	Download sale from a KSS homepage to
Payment method	Credit card payment through PayPal
Number issue	Sent by e-mail after check of receipt of fee.

2.3 Registration Fee List

Since a registration fee changes with products expected a registration method, please make sure the product's fee of your hope,

[Individual registration]----- \$ 9 (download)

[Corporation registration]----- \$199 (department license)

----- The numbers of PC * \$19 (ndividual number registration)

3. Individual Registration Method

Individual registration means that one person can register one set only for PC.

For purchased, only a user's registration number will notice by e-mail.
